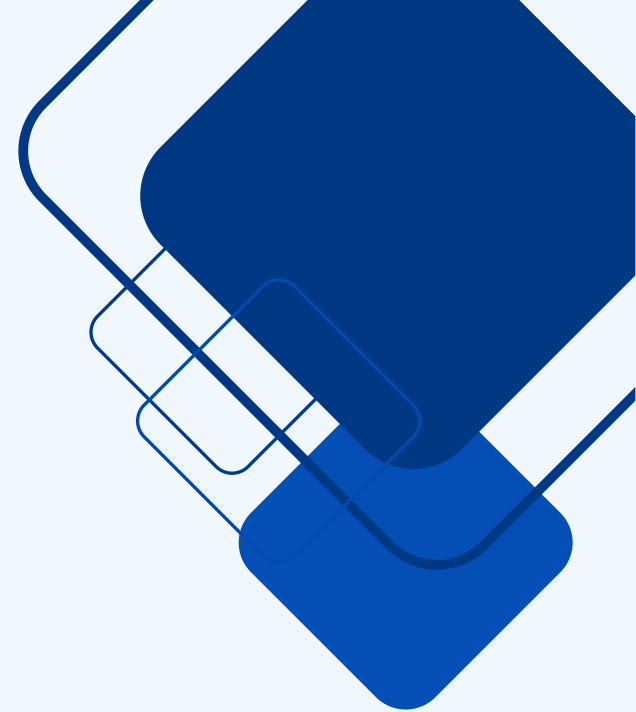
ABOUT EMLF
